BAND ASSEMBLY BILL 07-01-17-96

A bill of supplemental appropriation for the Governmental Operation of the Education Administration for fiscal year 1996

The District ____ Representative introduced the following bill on the ___26th __day of June 1996.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of supplemental programmatic funds for Youth Recreation Activities and Summer Youth Title II-B for fiscal year 1996.

Chapter 78

<u>Section 1:</u> Governmental Operations. The Band Assembly hereby appropriates carryover funds and supplemental appropriations for the Education Administration.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures, Two thousand six hundred forty-five dollars and no cents (\$2,645.00) for the Early Childhood program, Six thousand eight hundred forty-eight dollars and no cents (\$6,848.00) of the Education Administration , which amends the total to read Forty-five million seven hundred twenty-three thousand eight hundred three dollars and fifty-eight cents (\$45,723,803.58)

<u>Section 1.02</u>: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$10,000.00, provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administrative Policy Board to approve budget transfers within programs of up to 10% of the total program budget within a given budget line if the program is $\underline{\underline{under}}$ \$100,000.00 and $\underline{\underline{up}}$ to 5% if the program is \$100,000.00 $\underline{\underline{or}}$ greater.

All funds appropriated are maximum fund amounts and shall not be exceeded
