

**BAND ASSEMBLY BILL 07-01-09-96**

A bill of supplemental appropriation for the Governmental Operation of the Housing Administration, of the Executive Branch of Tribal Government, carryover funds for fiscal year 1996.

The District II Representative introduced the following bill on the 21st day of March 1996.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe Indians for the purpose of supplemental programmatic funds for '95 carryover, Project 777 c/o, HIP c/o, Housing Director c/o, for fiscal year 1996.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates carryover funds for the Housing Administration, .

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of five hundred eighteen thousand six hundred eighty-one dollars and forty-nine cents (\$581,681.49) for '95 carryover, four hundred fifty eight thousand four hundred thirty four dollars and eighty cents (\$458,434.80) for Project 777 carryover, one hundred ninety eight thousand one hundred two dollars and eighty-three cents (\$198,102.83) for HIP '95 carryover, eleven thousand five hundred eighty-two dollars and twenty-five cents (\$11,582.25) for Housing Director '95 carryover, for under Housing Administration, which amends the total to read thirty five million six hundred thirty-four thousand two hundred sixty-nine dollars and five cents (\$35,634,269.05).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:


Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$2,500.00, provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$2,500.00, the Band Assembly hereby authorizes the Administrative Policy Board to approve budget transfers within programs of up to 10% of the total program budget within a given budget line if the program is under \$100,000.00 and up to 5% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded
