

BAND ASSEMBLY BILL 07-01-11-96

A bill of supplemental appropriation for the Governmental Operation of the Health and Human Services and economic Development Division for fiscal year 1996

The District II Representative introduced the following bill on the 9th day of May 1996.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe Indians for the purpose of supplemental programmatic funds for Energy Assistance and Economic Development fiscal year 1996.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates supplemental appropriations for the Health and Human Services, and Economic Development Administration.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures, Seventeen thousand two hundred seventy two and no cents (\$17,272.00) for the Energy Assistance program of the Health and Human Services Administration and Four thousand seven hundred and forty six and no cents (\$4,746.00) for Summer youth program of the the Economic Development Administration, which amends the total to read Thirty six million one hundred ninety five thousand eight hundred ninety -four dollars and eighty five cents (\$36,195,894.85)

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$2,500.00, provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$2,500.00, the Band Assembly hereby authorizes the Administrative Policy Board to approve budget transfers within programs of up to 10% of the total program budget within a given budget line if the program is under \$100,000.00 and up to 5% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded


