

**BAND ASSEMBLY BILL 06-04-02-96**

A bill of supplemental appropriation for the Governmental Operation of the Health and Human Services Administration of the Executive Branch of Tribal Government fiscal year 1995.

The District II Representative introduced the following bill on the 26th day of October 1995.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe Indians for the purpose of supplemental appropriation of funds for governmental operations for fiscal year 1995.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates supplemental programmatic funds for the Energy Assistance Program '95 NFA#9 and Self-Governance National Rule-making Committee.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of Twelve thousand one hundred two dollars and no cents (\$12,102.00) under Health and Human Services one hundred thousand and no cents (\$100,000.00) under Administration, which amends the total to read twenty nine million four hundred eighty-two thousand nine hundred seven-three dollars and seventy-cents (\$29,482,973.70).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$2,500.00, provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$2,500.00, the Band Assembly hereby authorizes the Administrative Policy Board to approve budget transfers within programs of up to 10% of the total program budget within a given budget line if the program is under \$100,000.00 and up to 5% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded
