

BAND ASSEMBLY BILL 07-01-08-96

A bill of supplemental appropriation for the Governmental Operation of the Community Development, Education Administration, Public Works Administration of the Executive Branch of Tribal Government, for fiscal year 1996.

The District I Representative introduced the following bill on the 25th day of January 1996.
Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe Indians for the purpose of supplemental appropriation for governmental operations for fiscal year 1996.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates for the Gov't/District I Comm. Ctrs construction, class room/library construction and East Lake turn lane construction.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of seven million dollars and no cents (\$7,000,000.00) under Community Development, two hundred thousand dollars and no cents (\$200,000.00) under Education, fifty thousand dollars and no cents (\$50,000.00) under Public Works Administration, which amends the total to read thirty three million four hundred seventy two thousand six hundred seventy-seven dollars and fifty-nine cents (\$33,472,677.59).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:


Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$2,500.00, provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$2,500.00, the Band Assembly hereby authorizes the Administrative Policy Board to approve budget transfers within programs of up to 10% of the total program budget within a given budget line if the program is under \$100,000.00 and up to 5% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded



Introduced to the Band Assembly on this fifth day of February in the year one thousand nine hundred ninety six.


