

Band Assembly Bill 07-03-14-97

A bill of appropriation for Housing Authority of the Executive Branch of Tribal Government for fiscal year ending September 30, 1997.

The District I Representative introduced the following bill on the 29th day of April 1997.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for fiscal year ending September 30, 1997.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates funds for the Housing Administration for fiscal year ending September 30, 1997.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Seven hundred twenty four thousand dollars and no cents (\$724,000.00) for administrative, maintenance and elderly rehabilitation, Housing Improvement Program accounts and a Loan Officer position under the **Housing Administration**, which amends the **total Tribal Operations** to read Forty million two hundred forty two thousand seventy-six dollars and eighty-seven cents (\$40,242,076,87).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and budget concurs with the transfers. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administrative Policy Board to approve budget transfers within programs of up to 10% of the total program budget within a given budget line if the program is under \$100,000.00 and up to 5% if the program is \$100,000.00 or greater.

Section 2: The Mille Lacs Reservation Housing Authority shall continue to comply with the terms of Resolution 07-02-12-97 and provide monthly reports to the Chief Executive and Speaker of the Band Assembly.

All funds appropriated are maximum fund amounts and shall not be exceeded.
