BAND ASSEMBLY BILL 07-03-11-97

A bill of supplemental appropriations and carry over funds for the Governmental Operation of the Health and Human Services Administration, for fiscal year 1997.

The District __I_ Representative introduced the following bill on the_17th_day of March 1997.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of supplemental appropriation for Energy Assistance mod#7 grant and additional appropriation for Emergency/Energy Assistance Programs for fiscal year 1997.

Chapter 78

<u>Section 1:</u> Governmental Operations. The Band Assembly hereby appropriates supplemental appropriations for the Health and Human Services Administration.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Thirty-two thousand three hundred eighty dollars and no cents (\$32,380.00) for Energy Assistance grant Mod#7, Twenty thousand dollars and no cents (\$20,000.00) for the Emergency/Energy Assistance program under the **Health and Human Services Administration**, which amends the total Tribal Operations to read Thirty-seven million three hundred seventy-eight thousand three hundred twenty-seven dollars and forty cents (\$37,378,327.40).

<u>Section 1.02</u>: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$10,000.00, provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administrative Policy Board to approve budget transfers within programs of up to 10% of the total program budget within a given budget line if the program is under \$100,000.00 and up to 5% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded
