

BAND ASSEMBLY BILL 07-03-08-97

A bill of supplemental appropriations for the Governmental Operation of the Health and Human Services Administration for fiscal year 1997.

The District I Representative introduced the following bill on the _13th_ day of February 1997.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of Energy Assistant grant (Mod #5 and Mod #6) for fiscal year 1997.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates supplemental appropriations for the Health and Human Services for the fiscal year 1997.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Seventy-four thousand seven hundred fifty-three dollars and no cents (\$74,753.00) for Energy Assistance grant (EAP '97) mod #5, Six hundred forty-three dollars and no cents (\$643.00) for mod #6, under the Health and Human Services, which amends the total Tribal Operations to read Thirty-six million eight hundred eighty-five thousand six hundred ninety-five dollars and forty cents (\$36,885,695.40).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$10,000.00, provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$10,000.00, the Band Assembly hereby authorized the Administrative Policy Board to approve budget transfers within program of up to 10% of the total program budget within a given budget line if the program is under \$10,000.00 and up to 5% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
