

BAND ASSEMBLY BILL 07-03-06-97

A bill of supplemental appropriations and carry over funds for the Governmental Operation of the Administration and Health and Human Services Administration for fiscal year 1997.

The District II Representative introduced the following bill on the 21st day of January 1997.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of Chief Executive FY 1996 carryover, FY 1996 carryover funds for fifty cents a drink program, Energy Assistance/weatherization grant increase (Mod #4), Clinic 1996 carryover and FY 1996 IHS grant carryover for fiscal year 1997.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates supplemental appropriations and carryover funds for the Administration and Health and Human Services.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Seventy-seven thousand two hundred seventy-five dollars and seventeen cents (\$77,275.17) for Chief Executive '96 carryover under the Administration, Fifty thousand dollars and no cents (\$50,000.00) for IHS grant '96 carryover, One hundred fifty thousand dollars and no cents (\$150,000.00) for Clinic '96 carryover, Three thousand seventy-five dollars and no cents (\$3,075.00) for Energy Assistance/Weatherization grant increase, Sixty-seven thousand three hundred fifty-four dollars and seventy-nine cents (\$67,354.79) for fifty cents a drink program '96 carryover, under the Health and Human Services Administration, which amends the total Tribal Operations to read Thirty-six million eight hundred ten thousand two hundred ninety-nine dollars and forty cents (\$36,810,299.40).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$10,000.00, provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$10,000.00, the Band Assembly hereby authorized the Administrative Policy Board to approve budget transfers within program of up to 10% of the total program budget within a given budget line if the program is under \$10,000.00 and up to 5% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
