

Band Assembly Bill 07-03-17-97

A bill of carryover for Economic Development of the Executive Branch of Tribal Government for fiscal year ending September 30, 1997.

The District I Representative introduced the following bill on the 20th day of May 1997.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for fiscal year ending September 30, 1997.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates funds for the Corporate Commission for the fiscal year ending September 30, 1997.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Forty thousand dollars and no cents (\$40,000.00) for the Onamia Bakery expansion, One hundred thousand dollars and no cents (\$100,000.00) for St. Paul Companies Insurance Proposal, under Economic Development, which amends the **total Tribal Operations** to read Forty one million one hundred fifty one thousand nine hundred ninety two dollars and sixty two cents. (\$41,151,992.62).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administrative Policy Board to approve budget transfers within programs of up to 10% of the total program budget within a given budget line if the program is under \$100,000.00 and up to 5% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
