Band Assembly Bill 08-01-26-98

A bill of supplemental appropriations for Administration, Community Development, Education, Health and Human Services, Public Works of the Executive Branch of Tribal Government for fiscal year ending September 30, 1998.

The District I Representative introduced the following bill on the 26th day of March 1998.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1998.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Community Development, Education, Health and Human Services and Public Works for the fiscal year ending September 30, 1998.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Ninety thousand dollars and no cents (\$90,000.00) for WDSE TV Channel 8, under Administration, One million five hundred thousand dollars and no cents (\$1,500,000.00) for the District I-New Community Center, under Community Development, Twenty-seven thousand three hundred eighty-seven dollars and no cents (\$27,387.00) for increase to the Head Start Grant, under Education, One thousand three hundred forty-seven dollars and no cents (\$1,347.00) a grant increase in Energy Assistance Program, Thirty eight thousand six hundred eighty five dollars and no cents (\$38,685.00) for MN Department of Corrections Victim Services, Seven hundred seventy-two thousand three hundred ninety-one dollars and nineteen cents (\$772,391.19) for FY 1997 Clinic carryover, under Health and Human Services, Sixteen thousand nine hundred ninety-nine dollars and no cents (\$16,999.00) for FY 1997 carryover for Public Works/Solid Waste Dept, under Public Works, which amends the total Tribal Operations to read Fifty million, three hundred eighty-four thousand, two hundred dollars and ninety-five cents (\$50,384,200.95)

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs $\underline{u}\underline{p}$ to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers $\underline{o}\underline{v}\underline{e}$ \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of $\underline{u}\underline{p}$ to 50% of the total programs budget within a given budget line if the program is $\underline{u}\underline{n}\underline{e}$ \$100,000.00 and $\underline{u}\underline{p}$ to 20% if the program is \$100,000.00 or $\underline{g}\underline{e}\underline{e}\underline{e}\underline{e}\underline{e}\underline{e}$.

All funds appropriated are maximum fund amounts and shall not be exceeded.
