Ordinance 31-98

An ordinance of fiscal year 1997 carryover for Natural Resources of the Executive Branch of Tribal Government for fiscal year ending September 30, 1998.

The District _II_ Representative introduced the following bill on the _21st _day of _May_ 1998.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1998.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Natural Resources for the fiscal year ending September 30, 1998.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of, One million ninety-four thousand eight hundred fifty-four dollars and no cents (1,094,854.00) for carryover funds from FY '97 for Land Acquisition under **Department of Natural Resources**, which amends the **total Tribal Operations** to read Fifty-two million, nine thousand fifty-nine thousand, eight hundred ninety-three dollars and sixty-three cents (\$52,959,893.63).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
