Ordinance 28-98

An ordinance of carryover for fiscal year 1996 and fiscal year 1997 for Administration and Economic Development of the Executive Branch of Tribal Government for fiscal year ending September 30, 1998.

The District _III_ Representative introduced the following bill on the 21st day of _April_ 1998.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1998.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Economic Development for the fiscal year ending September 30, 1998.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Fifty thousand dollars and no cents (\$50,000.00) for fiscal '96 carryover playground construction in District II, Fifty thousand dollars and no cents (\$50,000.00) for fiscal year playground construction in District III, under **Administration**, Two hundred eight thousand four hundred twenty-two dollars and no cents (\$208,422.00) for the Band Entrepreneurial Fund FY 1997 carryover, under **Economic Development**, which amends the **total Tribal Operations** to read Fifty million, eight hundred seventy-three thousand, six hundred twenty dollars and sixty-three cents (\$50,873,620.63).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or <u>greater</u>.

All funds appropriated are maximum fund amounts and shall not be exceeded.
