

**Ordinance 01-98**

An ordinance of supplemental appropriations for Health and Human Services Administration of the Executive Branch of Tribal Government for fiscal year ending September 30, 1998.

The District I Representative introduced the following bill on the 2nd day of October 1997.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1998.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby authorizes and appropriates expenditures for the Health and Human Services Administration for the fiscal year ending September 30, 1998.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of One hundred eighty one thousand five hundred twenty-eight dollars and no cents (\$181,528.00) for the Iowa State Grant, Thirty four thousand dollars and no cents (\$34,000.00) for the Male Responsibility and Fathering Project Grant under **Health and Human Services**, which amends the **total Tribal Operations** to read Thirty one million, one hundred ninety-five thousand, six hundred eighty-one dollars and no cents (\$31,195,681.00).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 10% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 5% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
