Ordinance 20-98

An ordinance of supplemental appropriation for the Judicial Branch of Tribal Government for fiscal year ending September 30, 1997.

The District III Representative introduced the following bill on the 23rd day of January 1998.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1997.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Judicial Branch for the fiscal year ending September 30, 1997.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Nine thousand five hundred ninety-four dollars and no cents (\$9,594.00) an increase for The Mille Lacs Band of Ojibwe Circle Sentencing Project, under **Judicial**, which amends the **Fiscal Year 1997 total Tribal Operations** to read Forty-two million, five hundred sixty-nine thousand, six hundred eight dollars and forty-six cents (\$42,569,608.46);

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
