

**Ordinance 24-98**

An ordinance of supplemental appropriation and '97 carryover for Health and Human Services of the Executive Branch of Tribal Government for fiscal year ending September 30, 1998.

The District **I** Representative introduced the following bill on the **24th** day of February 1997.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1998.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Health and Human Services for the fiscal year ending September 30, 1998.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Two thousand eight hundred twenty-three dollars and no cents (\$2,823.00) for the Energy Assistance Grant increase, One thousand six hundred sixty-seven dollars and no cents (\$1,667.00) for Home Based Family Social Work Program, State grant increase, Thirty-eight thousand five hundred fifty-three dollars and five cents (\$38,553.05) for the Legal Aide Department, Two thousand four hundred fifty-seven dollars and no cents (\$2,457.00) for Social Nutrition State grant increase, under **Health and Human Services**, which amends the **total Tribal Operations** to read Forty-seven million, five hundred seventy-four thousand, one hundred sixty-four dollars and seventy-five cents (\$47,574,164.75)

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to **\$10,000.00** provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over **\$10,000.00**, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is **\$100,000.00** or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
