

Ordinance 16-98

An ordinance of Supplemental appropriation for Corporate Commission of Tribal Government for fiscal year ending September 30, 1998

The District I Representative introduced the following bill on the 21st day of January 1998.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1998.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Corporate Commission for the fiscal year ending September 30, 1998.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of, Seven hundred forty-seven thousand dollars and no cents (\$747,000.00) for the purchase Holbert property, under **Natural Resources**, Four hundred thousand dollars and no cents (\$400,000.00) for retail space expansion for Grand Casino Mille Lacs and Grand Casino Hinckley under **Corporate Commission** which amends **total Tribal Operations** to read Thirty-seven million, seven thousand, four hundred ninety-six dollars and eighty-eight cents (\$37,007,496.88)

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to **\$10,000.00** provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over **\$10,000.00**, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is **\$100,000.00** or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
