

**Ordinance 36-98**

An ordinance of fiscal year 1997 carryover for Housing Authority of Tribal Government for fiscal year ending September 30, 1998.

The District II Representative introduced the following bill on the 12th day of June, 1998.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1998.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Housing for fiscal year ending September 30, 1998.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of, Four hundred eighty-two thousand thirty-five dollars and twelve cents (\$482,035.12) for fiscal year 1997 carryover, under **Housing**, which amends the **Total Tribal Operations** to read Fifty-nine million, one hundred seventy-three thousand, five hundred thirty-six dollars and ninety-one cents (\$59,173,536.91).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to **\$10,000.00** provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over **\$10,000.00**, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is **\$100,000.00** or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
