## Ordinance 15-98

An ordinance of supplemental appropriation for Sentencing Circle of the Judicial Branch of Tribal Government for fiscal year ending September 30, 1998.

The District II Representative introduced the following bill on the 23rd day of December 1997.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1998.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Judicial for the fiscal year ending September 30, 1998.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Nine thousand five hundred ninety-four dollars and no cents (\$9,594.00) for The Mille Lacs Band of Ojibwe Circle Sentencing Project, under **Judicial**, which amends the **total Tribal Operations** to read Thirty-five million, eight hundred sixty thousand, four hundred ninety-six dollars and eighty-eight cents (\$35,860,496.88)

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Mille Lacs Band of Ojibwe Sentencing Circle Increase	\$9,594.00	\$ 505,238.00

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 10% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 5% if the program is \$100,000.00 or <u>greater</u>.

All funds appropriated are maximum fund amounts and shall not be exceeded.
