## Ordinance 27-99

An Ordinance of Supplemental Appropriation and Fiscal Year 1998 Carryover for Education of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 1999.

The District III Representative introduced the following Bill on the 15th day of October 1999.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1999.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Education for fiscal year ending September 30, 1999.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of One million four hundred ninety-eight thousand three hundred eighty dollars and no cents (\$1,498,380.00) for Tribally Controlled School Grant, Twenty thousand seven hundred seventy-eight dollars and no cents (\$20,778.00) for PSPP Grant Award, Two thousand five hundred eighty dollars and no cents (\$2,580.00) for ISEP, Nine thousand three hundred forty-six dollars and four cents (\$9,346.04) for JOM Grant Fiscal Year 1998 Carryover under Education which amends the Total Fiscal Year 1999 Tribal Operations to read Fifty-four million, nine hundred ninety-three thousand, nine hundred fourteen dollars and seventy-five cents (\$54,993,914.75),

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.
