

**Ordinance 20-99**

An Ordinance of Fiscal Year 1997 and 1998 carryover for Housing Authority of Tribal Government for fiscal year ending September 30, 1999.

The District II Representative introduced the following bill on the 15th day of July 1999.

**Preamble**

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1999.

**Chapter 78**

**Section 1: Governmental Operations.** The Band Assembly hereby appropriates and authorizes expenditures for Housing Authority for the fiscal year ending September 30, 1999.

**Section 1.01: Amendment to Section 1.02.** The Band Assembly hereby **Decreases** Two hundred twelve thousand one hundred sixty-one dollars and fourteen cents (\$212,161.14) from the Elderly Renovation line item. The Band Assembly hereby appropriates and authorizes the expenditures of Two hundred twelve thousand one hundred sixty-one dollars and fourteen cents, (\$212,161.14) for fiscal year 1997 and 1998 HIP elderly renovation carryover, Two hundred twelve thousand one hundred sixty-one dollars and fourteen cents (\$212,161.14) from elderly renovation to the DNR Acquisition Renovation, under **Housing Authority**, which amends the **total Tribal Operations** to read Fifty- three million one hundred ninety-two thousand eight hundred fifty-three dollars and seventy-three cents. (\$53,192,853.73)

**Section 1.02: Amendment to Section 1.03.** The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

**Section 1.03:** The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is **\$100,000.00** or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

**Section 1.04** All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.
