Ordinance 24-99

An Ordinance of Supplemental Appropriation for Health and Human Services of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 1999.

The District _I_ Representative introduced the following bill on the 17th day of September 1999.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1999.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Health and Human Services for fiscal year ending September 30, 1999.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Nineteen thousand twenty-four dollars and no cents (\$19,024.00) for Energy Assistance Program fiscal year 1999, Eighty thousand dollars and no cents (\$80,000.00) for Energy Assistance Program fiscal year 2000 under **Health and Human** Services, which amends the **Total Fiscal Year 1999 Tribal Operations** to read Fifty-three million, three hundred sixty-nine thousand, five hundred forty-five dollars and thirty-nine cents (\$53,369,545.39),

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.
