

## Ordinance 15-99

An Ordinance of Supplemental Appropriations and Fiscal Year 1998 Carryover for Community Development and Education of the Executive Branch of Tribal Government for fiscal year ending September 30, 1999 and adding an amendment to Ordinance 17-98.

The District III Representative introduced the following bill on the 4th day of May 1999.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1999 and adding an amendment to Ordinance 17-98.

### Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures, Community Development and Education for the fiscal year ending September 30, 1999.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Five hundred sixty-five thousand seven hundred thirty-two dollars and no cents (\$566,732.00) for FmHa Construction Funds for Fiscal Year 1998 Carryover, under **Community Development**, Nine thousand eight hundred fifty-five dollars and no cents (\$9,855.00) for Program Development Assistance and Training grant, under **Education**, which amends the **total Tribal Operations** to read Fifty million seven hundred and six thousand two hundred and sixty-eight dollars and seventeen cents, (\$50,706,268.17).

- Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is **\$100,000.00** or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.

Section 1.05 Repeal and Replace Ordinance 17-98 §26(b)(2)  
An attorney from the Office of the Solicitor General shall review all contracts over \$5000.
