

## Ordinance 16-99

An Ordinance of Supplemental Appropriations for the Housing Authority of the Tribal Government for fiscal year ending September 30, 1999.

An Ordinance of Supplemental Appropriations for Health and Human Services and Community Development of the Executive Branch of Tribal Government for fiscal year ending September 30, 1999.

The District II Representative introduced the following bill on the 3rd day of June 1999.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1999.

### Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures, under Housing Authority for the fiscal year ending September 30, 1999.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Three hundred thousand dollars and no cents (\$300,000.00) for Elderly Renovation for District I, II and III, under **Housing Authority**, Eight hundred ninety-seven dollars and no cents (\$897.00) for FY 99 Food Distribution Grant increase under **Health and Human Services**, Three hundred thirty thousand dollars and no cents (\$330,000.00) for additional construction funds for a pedestrian overpass on highway 169 under **Community Development** which amends the **total Tribal Operations** to read Fifty-one million three hundred thirty-seven thousand one hundred sixty-five dollars and seventeen cents, (\$51,337,165.17).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to **\$10,000.00** provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over **\$10,000.00**, the Band Assembly hereby authorizes the Administration Policy Board to approve

budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is **\$100,000.00** or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.

Section 1.05 Repeal and Replace Ordinance 17-98 §26(b)(2)  
An attorney from the Office of the Solicitor General shall review all contracts over \$5000.
