## Ordinance 13-99

An Ordinance of Supplemental Appropriations for Economic Development and Bonus Distribution for Governmental operations in fiscal year ending September 30, 1999.

The District \_III\_ Representative introduced the following bill on the \_30th\_ day of April 1999.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for economic development and governmental operations for fiscal year ending September 30, 1999.

## Chapter 78

Section 1: Economic Development and Bonus Distribution. The Band Assembly hereby appropriates and authorizes expenditures for Economic Development and Bonus Distribution for fiscal year ending September 30, 1999.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of Five million four hundred eighty thousand nine hundred dollars and no cents (\$5,480,900.00) for **Economic Development**, Two million four hundred thousand dollars and no cents (\$2,400,000.00) for **Bonus Distribution** amends the **total Tribal Operations** to read Fifty million, ninety-one thousand, five hundred and seventy-two dollars and seventeen cents. (\$50,091,572.17).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Appropriation for Tribal Distribution becomes null and void if the Bureau of Indian Affairs fails to approve the plan prior to distribution. Furthermore, appropriation will lapse at the end of the fiscal year if not distributed by that time.

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and up to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.
