

**Ordinance 24-99**

An Ordinance of Supplemental Appropriation for Health and Human Services of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 1999.

The District I Representative introduced the following bill on the 17th day of September 1999.

**Preamble**

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1999.

**Title I.**

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Health and Human Services for fiscal year ending September 30, 1999.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Nineteen thousand twenty-four dollars and no cents (\$19,024.00) for Energy Assistance Program fiscal year 1999, Eighty thousand dollars and no cents (\$80,000.00) for Energy Assistance Program fiscal year 2000 under **Health and Human Services**, which amends the **Total Fiscal Year 1999 Tribal Operations** to read Fifty-three million, three hundred sixty-nine thousand, five hundred forty-five dollars and thirty-nine cents (\$53,369,545.39),

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.
