

Ordinance 07-99

An ordinance of supplemental appropriation for Administration and Health and Human Services of the Executive Branch of Tribal Government for fiscal year ending September 30, 1999.

The District III Representative introduced the following bill on the 29th day of January 1999.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1999.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Administration and Health and Human Services for the fiscal year ending September 30, 1999.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Seven thousand four hundred eighty-two dollars and no cents (\$7,482.00) for the Special Focus Grant Fiscal Year 1998 carryover, One thousand one hundred thirty-one dollars and nineteen cents (\$1,131.19) for Service Learning Project fiscal year 1998 carryover, under **Administration**, which amends the **total Tribal Operations** to read Thirty-nine million, six hundred sixty-two thousand, one hundred eighty-nine dollars and fifty-one cents (\$39,662,189.51).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to **\$10,000.00** provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over **\$10,000.00**, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is **\$100,000.00** or greater.
