

## ORDINANCE 05-99

A Supplemental Appropriation Bill and Fiscal Year 1998 carryover for Administration, Economic Development, Education, Health and Human Services, Natural Resources and Public Safety of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 1999.

The District III Representative introduced the following bill on the 30th day of December 1998.  
Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal year ending September 30, 1999.

### Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Economic Development, Education, Health and Human Services, Natural Resources and Public Safety for fiscal year ending September 30, 1999.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Eighty-four thousand three hundred nine dollars and no cents (\$84,309.00) for Fiscal Year 1998 carryover, One hundred nine thousand six hundred nine dollars and seventy-nine cents (\$109,609.79) for half BIA guaranteed Loan settlement, under **Administration**, One hundred nine thousand six hundred nine dollars and seventy-nine cents (\$109,609.79) for 2<sup>nd</sup> half of the BIA guaranteed Loan settlement, under **Economic Development**, Seven hundred ten thousand fifty-seven hundred dollars and fifty cents (\$710,057.50) for Fiscal Year 1998 Contingency funds carryover, Sixty-seven thousand seven hundred seventy dollars and twenty-four cents (\$67,770.24) for Tribal Jobs Program Fiscal Year 1998 carryover, Fourteen thousand two hundred twenty-two dollars and thirty-one cents (\$14,222.31) for Adult Education Program Fiscal Year 1998 carryover, under **Education**, Twenty thousand dollars and no cents (\$20,000.00) for Crisis Nursery grant, Forty-one thousand eight hundred twenty-five dollars and no cents (\$41,825.00) for Energy Assistance grant, One hundred thirty-nine dollars and no cents (\$139.00) for EAP/Weatherization grant, Two thousand seventy-five dollars and no cents (\$2,075.00) for Child Welfare Services Plan, Sixteen thousand five hundred seventy-one dollars and no cents (\$16,571.00) for Iowa State University Outreach project grant, One thousand three hundred ninety-six dollars and no cents (\$1,396.00) for Fiscal Year 1998 Food Distribution grant, Five thousand dollars and no cents (\$5,000.00) for Fiscal Year 1999 Energy Assistance grant, under **Health and Human Services**, Twenty-three thousand eight hundred seventy-six dollars and forty-one cents (\$23,876.38) for Waste Water Consultant Fiscal Year 1998 carryover, under **Natural Resources**, Thirty-five thousand dollars and no cents (\$35,000.00) for Fiscal Year 1998 carryover, under **Public Safety**, which amends the **Total Fiscal Year 1999 Tribal Operations** to read Thirty-nine million, five hundred thirteen thousand, four hundred thirty-two dollars and fifty-nine cents (\$39,513,432.59),

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:
