Ordinance 22-00

An Ordinance of supplemental appropriation for Health and Human Services, and Administration of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2000.

The District II Representative introduced the following Bill on the 14th day of June 2000.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for the fiscal year ending September 30, 2000.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Health and Human Services, and Administration for fiscal year ending September 30, 2000.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of One hundred fifty thousand dollars and no cents (\$150,000.00) for Contract Health Services, Thirty-four thousand five hundred eighty-one dollars and no cents (\$34,581.00) for Contract Pharmacist, Ten thousand dollars (\$10,000.00) for Community Dental Services, One hundred fifty thousand dollars and no cents (\$150,000.00) for Pharmaceutical Supplies under **Health and Human Services**, which amends the **Total Fiscal Year 2000 Tribal Operations** to read Sixty-one million sixty-five thousand seventy-two hundred dollars and seventy-seven cents (\$61,065,072.77).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.
