Ordinance 12-00

An Ordinance of Supplemental Appropriation for Health and Human Services, Fiscal Year 1999 Carryover for Natural Resources of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2000.

The District III Representative introduced the following Bill on the 10th day of January 2000.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for fiscal years ending September 30, 2000.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Health and Human Services and Natural Resources for fiscal year ending September 30, 2000.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Five thousand dollars and four hundred and eighteen dollars and no cents (\$5,418.00) for the Energy Assistance grant, Two thousand two hundred twenty dollars and no cents (\$2,220.00) for Energy Assistance Grant under **Health and Human Services**, Twelve thousand six dollars and forty-three cents, (\$12,006.43) for EPA Air pollution grant fiscal year 1999 carryover under **Natural Resources** which amends the **Total Fiscal Year 2000 Tribal Operations** to read Forty nine million seven hundred thirty thousand eight hundred seventy-five dollars and ninety-seven cents. (\$49,730,875.97)

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.
