

**Ordinance 13-01**

An ordinance of supplemental appropriation for Community Development of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2001.

The District II Representative introduced the following Bill on the 30th day of January 2001.

**Preamble**

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for the fiscal year ending September 30, 2001.

**Title I.**

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Community Development for fiscal year ending September 30, 2001.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of a Ten million six hundred thousand dollars and no cents (\$10,600,000.00) for the Housing Initiative Plan under **Community Development** which amends the **Total Fiscal Year 2001 Tribal Operations** to read Sixty-one million six hundred eighty-eight thousand seven hundred nine dollars and sixty-one cents (\$61,688,709.61).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is **\$100,000.00** or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.

**Band Assembly Bill 09-03-13-01**

A Bill of supplemental appropriation for Community Development of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2001.

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.
