

Ordinance 11-01

An Ordinance of supplemental appropriation for Administration of the Legislative Branch and Natural Resources and Public Safety of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2001.

The District III Representative introduced the following Bill on the 9th day of January 2000.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for the fiscal year ending September 30 2001.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Natural Resources and Public Safety for fiscal year ending September 30, 2001.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Nineteen thousand six hundred dollars and no cents (\$19,600.00) to be used to provide food and beverage at the business economic development meetings held by the Corporate Commission, under **Administration**; Decrease of forty-three thousand dollars and no cents (\$43,000.00) FEMA Grant made in error under **Natural Resources**; Forty-three thousand dollars and no cents (\$43,000.00) FEMA Grant, under **Public Safety**, which amends the **Total Fiscal Year 2001 Tribal Operations** to read Forty-nine million seven hundred thousand eight hundred thirty-eight dollars and sixty-five cents (\$49,700,838.65).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to **\$10,000.00** provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over **\$10,000.00**, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is **\$100,000.00** or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent
