

## Ordinance 07-01

An Ordinance of supplemental appropriation for Health and Human Services of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2001.

The District III Representative introduced the following Bill on the 22nd day of November 2000.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for the fiscal years ending September 30 2001.

### Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Health and Human Services for fiscal years ending September 30, 2001.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Two hundred eighty-five thousand nine hundred nine dollars and no cents (\$285,909.00) for Traditional Healers salary and fringe benefits, under **Health and Human Services**, which amends the **Total Fiscal Year 2001 Tribal Operations** to read Forty-seven million three hundred eighty thousand one hundred twenty-one dollars and nineteen cents (\$47,380,121.19).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is **\$100,000.00** or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent
