## Ordinance 24-01

An ordinance of supplemental appropriation and fiscal year 2000 carryover for Administration, Education, Health and Human Services and Natural Resources of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2001.

The District II Representative introduced the following Bill on the 24<sup>th</sup> day of May 2001.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for the fiscal year ending September 30, 2001.

## Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Education, Health and Human Services and Natural Resources for fiscal year ending September 30, 2001.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Thirty-one thousand one hundred twenty-four dollars and fiftyfour cents (\$31,124.56) carryover into line item 100-200-6805. Nine thousand six hundred sixtytwo dollars and no cents (\$9,662.00) for 2001 YINR Summer Youth Program, under Administration; One hundred thousand six hundred ninety-four dollars and fifty-one cents (\$100,694.51) for State Equalization, Fifty-three thousand four hundred eighteen dollars and no cents (\$53,418.00) for Federal Head Start, Fifty-four thousand eight hundred thirty-three dollars and no cents (\$54,833.00) for Local Intervention Grant for Self Sufficiency (LIGSS), Twentythree thousand three hundred dollars and no cents (\$23,300.00) for Transportation match grant award, Fifty-six thousand one hundred forty-two dollars and no cents (\$56,142.00) for Federal Early Head Start match grant award, Fifty-one thousand one hundred thirty-seven dollars and no cents (\$51,137.00) for Band TANF, One hundred three thousand two hundred seventy-six dollars and no cents (\$103,276.00) for Americorp, under Education; Seventy-five thousand dollars and no cents (\$75,000.00) for Emergency Assistance, Two thousand four hundred fifty-three dollars and no cents (\$2,453.00) for IHS Self-Governance Annual Funding Agreement, under Health and Human Services; Fifteen thousand dollars and no cents (\$15,000.00) for litigation fiscal year 2000 carryover, under Natural Resources; which amends the Total Fiscal Year 2001 Tribal Operations to read Seventy-two million sixty-one thousand two hundred thirty-nine dollars and thirty-nine cents (\$72,061,239.39).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.
