Ordinance 14-01

An Ordinance of supplemental appropriation for Natural Resources of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2001.

The District I Representative introduced the following Bill on the 1st day of February 2000.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for the fiscal year ending September 30 2001.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Natural Resources for fiscal year ending September 30, 2001.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of seven hundred thousand dollars and no cents (\$700,000.00) for additional award of attorney fees paid to Ziontz, Chestnut, Varnell & Slonim, three hundred thousand dollars and no cents (\$300,000.00) to be held in reserve in an interest bearing account for future boundary and treaty litigation, and two million thirty-eight thousand eight hundred dollars and no cents (\$2,038,800.00) for treaty distribution to all enrolled Band members as of February 2, 2001 to occur in March 2001, any additional interest earned after January 31, 2001 shall be added to the future litigation reserve fund, under **Natural Resources**; which amends the **Total Fiscal Year 2001 Tribal Operations** to read Sixty-four million seven hundred twenty-seven thousand five hundred nine dollars and sixty-one cents (\$64,727,509.61).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Tribal Operation Fiscal Year 2001 Natural Resources Ziontz Chestnut Attorney Fee Award Litigation Reserve Fund Treaty Distribution Supplemental/Carryover Amended Amount \$ 700,000.00 \$ 300,000.00 \$ 2,038,800.00 \$ \$6,513,034.30

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.
