## Ordinance 33-02

An Ordinance of Supplemental Appropriation for Administration, Community Development, Education, Health and Human Services, and the Mille Lacs Reservation Housing Authority of the Tribal Government for Fiscal Years ending September 30, 2002 and September 30, 2003.

The District II Representative introduced the following Bill on the fourth day of September 2002.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for the fiscal years ending September 30, 2002 and September 30, 2003.

## Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Community Development, Education, Health and Human Services, and the Mille Lacs Reservation Housing Authority for fiscal years ending September 30, 2002 and September 30, 2003.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of; Twenty five thousand seven hundred sixty-six dollars and seventy-one cents (\$25,766.71) for FY'01 carryover for Critical Professions, under Administration; Seven hundred fifty thousand dollars and no cents (\$750,000.00) for Housing Initiative for home purchasing, under Community Development; Decrease Six hundred thousand dollars and no cents (\$600,000.00) for 204-321 forward funding done in error, Three hundred forty-eight thousand five hundred eighty-nine dollars and eighty-nine cents (\$348,589.89) for FY'00 BIA federal carryover, under Education; Decreasing Forty three thousand fifty-two dollars and no cents (\$43,052.00) Home Visiting Grant, Decreasing Forty-three thousand two hundred dollars and no cents (\$-43,200.00) Health Disparities Grant, under Health and Human Services; One hundred sixty thousand dollars and no cents (\$160,000.00) for Transitional trailer houses for Districts II & III, under Housing Authority; which amends the Total Fiscal Year 2002 Tribal Operations to read Eighty-eight million two hundred sixteen thousand five hundred two dollars and eleven cents (\$88,216,502.11). and;

Eighty-five thousand fifty-four dollars and no cents (\$84,054.00) for FY '01 carryover for Critical Professions, under **Administration**; Forty three thousand fifty-two dollars and no cents (\$43,052.00) fiscal year 2003 Home Visiting Grant, Forty-three thousand two hundred dollars and no cents (\$43,200.00) fiscal year 2003 Health Disparities Grant, under **Health and Human Services**; which amends the **Total Fiscal Year 2003 Tribal Operations** to read Fifty-eight million three hundred seventy-seven thousand five hundred eighty-eight dollars and no cents (\$58,377,588.00).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for capital construction projects shall be appropriated to align with the project length so as to automatically carry-over to the next fiscal year if appropriated funds remain and if the project is not completed within Fiscal Year 2002. If, for any reason, the project length runs over the contracted period for construction causing construction costs to exceed the appropriated amount, a written Change Order shall immediately be routed to the Band Assembly for appropriate action.
