An Ordinance of supplemental appropriation for Community Development and Natural Resources of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2001.

An Ordinance of supplemental appropriation for Community Development of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2002.

The District II Representative introduced the following Bill on the 23rd day of October 2001.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for the fiscal years ending September 30, 2001, and September 30, 2002

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Community Development and Natural Resources for fiscal years ending September 30, 2001, and September 30, 2002.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Seven thousand one hundred thirty-four dollars and no cents (\$7,134.00) for Transportation Grant, under **Community Development**; One hundred sixty-five thousand dollars and no cents (\$165,000.00) for Environmental Programs (GAP) Air Quality FEMA, Eighty-six thousand nine hundred eighteen dollars and no cents (\$86,918.00) for Air Quality Grant, under **Natural Resources**; which amends the **Total Fiscal Year 2001 Tribal Operations** to read Seventy-eight million five hundred seventy-seven thousand sixty-nine dollars and eighty-eight cents (\$78,567,069.88), **and**;

Fifty-seven thousand dollars and no cents (\$57,000.00) for BIA Grant, Thirty-nine thousand two hundred dollars and no cents (\$39,200.00) for IHS Grant, under **Community Development**; which amends the **Total Fiscal Year 2002 Tribal Operations** to read Fifty-nine million five hundred sixty-three thousand five hundred fifty-six dollars and no cents (\$59,563,556.00).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03 The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$10,000.00 per line item, provided that the transfers are allowable under grant provisions, if applicable. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administrative Policy Board to approve budget transfers within programs of up to 50% of the total program budget transfers within a given budget line item if the program is under one hundred thousand dollars and up to 20% if the program is one hundred thousand dollars or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for construction projects, shall be automatically carried-over to the next fiscal year, if total amount appropriated is unspent.




