Ordinance 37-03

An Ordinance of Supplemental Appropriation, Carryover, and Budget Revision for Administration, Community Development, Education, Housing, and Public Safety of the Tribal Government for Fiscal Year ending September 30, 2003.

The District II Representative introduced the following Bill on the 28th day of July 2003.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for the Fiscal Year ending September 30, 2003.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Community Development, Education, Housing, and Public Safety for Fiscal Year ending September 30, 2003.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Sixty five thousand dollars and no cents (\$65,000.00) for Utility Expenses 201-6700, Fifteen thousand dollars and no cents (\$15,000.00) for Insurance 201-6120, under Administration; Fifty seven thousand seven hundred dollars and no cents (\$ 57,700.00) for IHS New Septic Grant, Fifty six thousand eight hundred fifty five dollars and no cents (\$56,855.00) for IHS Utility Hookup Grant, One hundred forty five thousand seven hundred forty dollars and no cents (\$145,740.00) for Isle Park Construction, under Community **Development**; One hundred fifteen thousand thirty four dollars and no cents (\$115,034,00) for ISEP Bureau Grant, Two hundred two thousand seven hundred fifteen dollars and no cents (\$202,715.00) for IASA Bureau Grant, One hundred three dollars and ninety six cents (\$103.96) for Digital Divide Grant, under Education; Fifty thousand five hundred fourteen dollars and eighty eight cents (\$50,514.88) for Carryover of COPS in School Grant, Three thousand five hundred eighty seven dollars and forty eight cents (\$3,587.48) for Carryover of Injury Prevention Grant, under Public Safety; which amends the Total Fiscal Year 2003 Tribal Operations to read One hundred two million three hundred forty six thousand one hundred twenty nine dollars and twenty seven cents (\$102,780,693.10).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds and carryover for the following:

Section 1.02.1: The Band Assembly hereby authorizes the transfer of programmatic funds for the following:

Education

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for capital construction projects shall be appropriated to align with the project length so as to automatically carry-over to the next fiscal year if appropriated funds remain and if the project is not completed within Fiscal Year 2003. If, for any reason, the project length runs over the contracted period for construction causing construction costs to exceed the appropriated amount, a written Change Order shall immediately be routed to the Band Assembly for appropriate action.
