Ordinance 01-03

An Ordinance of Supplemental Appropriation and Budget Revision for Administration, Community Development, Education, and Natural Resources of the Tribal Government for Fiscal Years ending September 30, 2002, and September 30, 2003.

The District I Representative introduced the following Bill on the 17th day of October 2002.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for the fiscal years ending September 30, 2002, and September 30, 2003.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Community Development, Education, and Natural Resources for fiscal years ending September 30, 2002, and September 30, 2003.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Twenty five thousand dollars and no cents (\$25,000.00) for Solid Waste Department, under Community Development; amends the Total Fiscal Year 2002 Tribal Operations to read Eighty eight million three hundred eighty six thousand seven hundred fifty four dollars and eleven cents (\$88,386,754.11), and

Thirty thousand dollars and no cents (\$30,000.00) for the Mille Lacs Pow-wow, under Administration; 2.8 Million (\$2,800,000.00) for Housing Initiative 100-235-7200, under Community Development; One hundred seventy thousand twenty one dollars and no cents (\$170,021.00) for State FY'03 Minnesota Family Investment Program, Seventy four thousand six hundred fifteen dollars and no cents (\$74,615.00) for Local Intervention Grant Support Services, Ninety five thousand six hundred thirty dollars and no cents (\$95,630.00) for Children for Learning Child Care Grant, under Education; One hundred fifty seven thousand dollars and no cents (\$157,000.00) for Immersion Grounds, under Natural Resources; which amends the Total Fiscal Year 2003 Tribal Operations to read Sixty one million six hundred eighteen thousand six hundred two dollars and no cents (\$61,618,602.00).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for capital construction projects shall be appropriated to align with the project length so as to automatically carry-over to the next fiscal year if appropriated funds remain and if the project is not completed within Fiscal Year 2002. If, for any reason, the project length runs over the contracted period for construction causing construction costs to exceed the appropriated amount, a written Change Order shall immediately be routed to the Band Assembly for appropriate action.
