Ordinance 37-04

An Ordinance of Supplemental Appropriation, and Budget Revision for Administration, Chief Executive, Education and Health and Human Services of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2004 and September 30, 2005.

The District II Representative introduced the following Bill on the 4th day of August 2004.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2004 and September 30, 2005.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Chief Executive, Education, and Health and Human Services of the Executive Branch, Judicial Branch and Legislative Branch for fiscal year ending September 30, 2004 and September 30, 2005.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Twenty one thousand three hundred nineteen dollars and no cents (\$21,319.00) for Urban concert tickets, under **Administration**; Twenty two thousand sixty four dollars and no cents (\$22,064.00) for Chief Executive concert tickets, under **Chief Executive**, One hundred ninety one thousand dollars and no cents (\$191,000.00) for AmeriCorps Federal Grant, under **Education**; Eighty thousand five hundred eighty seven dollars and no cents (\$80,587.00) for concert tickets, Fifteen thousand dollars and no cents (\$15,000.00) for District II to cover Funeral rooms and extra Valley fair tickets, under **Legislative**, which amends the **Total Fiscal Year 2004 Tribal Operations** to read One hundred million eight hundred nine thousand five hundred seven dollars and forty five cents (\$100,809,507.45) and

Twenty two thousand one hundred seventy two dollars and no cents (\$22,172.00) for Urban concert tickets, under **Administration**; Twenty two thousand nine hundred forty seven dollars and no cents (\$22,947.00) for concert tickets, under **Chief Executive**; Eighty three thousand eight hundred ten dollars and no cents (\$83,810.00) for concert tickets, Twenty one thousand nine hundred eighty two dollars and nineteen cents (\$21,982.19) for Severance, Eight thousand three hundred four dollars and no cents (\$8,304.00) for Pension, under **Legislative**; which amends the **Total Fiscal Year 2005 Tribal Operations** to read Fifty one million eight hundred twenty thousand one hundred ninety nine dollars and nineteen cents (\$51,820,199.19).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

Section 1.03 The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy

Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is **\$100,000.00** or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for capital construction projects shall be appropriated to align with the project length so as to automatically carry-over to the next fiscal year if appropriated funds remain and if the project is not completed within Fiscal Year 2004. If, for any reason, the project length runs over the contracted period for construction causing construction costs to exceed the appropriated amount, the Band Assembly must be notified so as to take appropriate action.
