## Ordinance 30-04

An Ordinance of Supplemental Appropriation for Community Development of the Executive Branch, and Legislative Branch of Tribal Government for Fiscal Year ending September 30, 2004.

The District II Representative introduced the following Bill on the 17th day of June 2004.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2004.

## Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Community Development of the Executive Branch and Legislative Branch for fiscal year ending September 30, 2004.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: One million dollars and no cents (\$1,000,000.00) for Home Renovation Loan Program, Fifty thousand dollars and no cents (\$50,000.00) for a Housing Attorney, under Community Development; Twenty one thousand one hundred sixty dollars and no cents (\$21,160.00) for Legislative 100-103, under Legislative, which amends the Total Fiscal Year 2004 Tribal Operations to read Seventy three million four hundred fifty four thousand seven hundred nine one dollars and thirty seven cents (\$73,454,791.37), and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

Section 1.03 The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for capital construction projects shall be appropriated to align with the project length so as to automatically carry-over to the next fiscal year if appropriated funds remain and if the project is not completed within Fiscal Year 2004. If, for any reason, the project length runs over the contracted period for construction causing construction costs to exceed the appropriated amount, the Band Assembly must be notified so as to take appropriate action.
