

Ordinance 42-04

An Ordinance of Supplemental Appropriation for Community Development of the Executive Branch and Office of Management and Budget of the Legislative Branch of the Tribal Government for Fiscal Year ending September 30, 2005.

The District III Representative introduced the following Bill on the 24th day of September 2004.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2005.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Community Development and Legislative for fiscal year ending September 30, 2005.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Twenty million three hundred nine thousand nine hundred seventy two dollars and no cents (\$20,309,972.00) for Housing department, under **Community Development**; Fifty thousand dollars and no cents (\$50,000.00) for the discretionary loan program, under **(OMB)Legislative**; which amends the **Total Fiscal Year 2005 Tribal Operations** to read Seventy two million one hundred eighty thousand seven hundred seventeen dollars and nineteen cents (\$72,180,717.19) and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

Section 1.03 The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is \$100,000.00 or greater.


All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for capital construction projects shall be appropriated to align with the project length so as to automatically carry-over to the next fiscal year if appropriated funds remain and if the project is not completed within Fiscal Year 2004. If, for any reason, the project length runs over the contracted period for construction causing construction costs to exceed the appropriated amount, the Band Assembly must be notified so as to take appropriate action.
