

Ordinance 01-05

An Ordinance of Supplemental Appropriation, and Budget Revision for Administration, Education, Health and Human Services, and Natural Resources of the Executive Branch of the Tribal Government for Fiscal Year ending September 30, 2004; and,

An Ordinance of Supplemental Appropriation for Department of Justice of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2005.

The District III Representative introduced the following Bill on the 7th day of October 2004.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2004.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Department of Justice, Education, Health and Human Services, and Natural Resources for fiscal years ending September 30, 2004, and September 30, 2005.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Eleven thousand five hundred fifty eight dollars and no cents (\$11,558.00) for Community Services Block Grant, Five thousand two hundred seventeen dollars and no cents (5,217.00) for Elderly Nutrition 220-406, under **Health and Human Services**; Fifty seven thousand eight hundred forty eight dollars and no cents (\$57,848.00) for Fire Preparedness, under **Natural Resources**; which amends the **Total Fiscal Year 2004 Tribal Operations** to read One hundred five million three hundred forty four thousand five hundred forty three dollars and forty five cents (\$105,344,543.45) and

Fifty seven thousand six hundred twenty seven dollars and no cents (\$57,627.00) for OSG 100-215, under **Department of Justice**; Thirty four thousand five hundred dollars and no cents (\$34,500.00) for the purchase of a new handicap van, Ten thousand dollars and no cents (\$10,000.00) for additional supplement for handicap van, under **Health and Human Services**; which amends the **Total Fiscal Year 2005 Tribal Operations** to read Seventy two million four hundred forty one thousand seven hundred twenty nine dollars and nineteen cents (\$72,441,729.19).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
