Ordinance 07-05

An ordinance of Supplemental Appropriation for Natural Resources of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2005

The District II Representative introduced the following Bill on the 30th day of November 2004.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriation for governmental operations for the fiscal year ending September 30, 2005.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Natural Resources for fiscal year ending September 30, 2005.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Three hundred thirty four thousand one hundred forty eight dollars and no cents (\$334,148.00) for Cultural Resources, under **Natural Resources**; which amends the **Total Fiscal Year 2005 Tribal Operations** to read Seventy three million twenty four thousand four hundred thirty eight dollars and nineteen cents (\$73,024,438.19).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following (attached hereto as "Exhibit A"):

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.03 The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04 All funds appropriated for capital construction projects shall be appropriated to align with the project length so as to automatically carryover to the next fiscal year if appropriated funds remain and if the project is not completed within Fiscal Year 2005. If, for any reason, the project length runs over the contracted period for construction causing construction costs to exceed the appropriated amount, the Band Assembly must be notified so as to take appropriate action.
