

Ordinance 35-05

An Ordinance of Supplemental Appropriation and Budget Revision for Administration, and Health Human Services of the Executive Branch of the Tribal Government for Fiscal Year ending September 30, 2005.

The District II Representative introduced the following Bill on the 21st day of June 2005, which was vetoed by the Chief Executive on June 27, 2005. Compromise was held, and Bill is re-introduced on this 29th day of June 2005.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for the Fiscal Year ending September 30, 2005.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration and Health and Human Services for fiscal year ending September 30, 2005.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Twenty seven thousand six hundred fifty dollars and no cents (\$27,650.00) for Public Health 220-421, Three thousand one hundred nineteen dollars and no cents (\$3,119.00) for Energy Assistance Program 220-453, Four thousand seven hundred ninety two dollars and no cents (\$4,792.00) for WC 220-450, Twenty thousand dollars and no cents (\$20,000.00) for Wisdom Steps, Five hundred eighty six thousand six hundred dollars and no cents (\$586,600.00) for Pharmacy 220-424, under **Health and Human Services**; which amends the **Total Fiscal Year 2005 Tribal Operations** to read One hundred three million fifteen thousand two hundred forty four dollars and thirty two cents (\$103,015,244.32).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds and carryover for the following:
