

**Ordinance 04-05**

An Ordinance of Supplemental Appropriation for Education, and Natural Resources of the Executive Branch of Tribal Government for Fiscal Year ending September 30, 2005.

The District II Representative introduced the following Bill on the 28th day of October 2004.

**Preamble**

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2005.

**Title I**

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Education and Natural Resources for fiscal year ending September 30, 2005.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Eighty seven thousand one hundred seven dollars and no cents (\$87,107.00) for Education Partnership, under **Education**; Two thousand dollars and no cents (\$2,000.00) for Well Installation, under **Natural Resources**; which amends the **Total Fiscal Year 2005 Tribal Operations** to read Seventy two million six hundred eighty thousand eight hundred thirty six dollars and nineteen cents (\$72,680,836.19).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

Section 1.03 The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
