Ordinance 25-06

An Ordinance of Supplemental Appropriation for April 2006 Bonus Distribution of the Tribal Government for Fiscal Year ending September 30, 2006.

The District III Representative introduced the following Bill on the 28th day of March, 2006.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal years ending September 30, 2006 and September 30, 2007.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Bonus Distribution for fiscal year ending September 30, 2006.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two million nine hundred seventy eight thousand eight hundred eighty dollars and no cents (\$2,978,880.00) for Minors Trust, Five million eight hundred forty four thousand eighty dollars and no cents (\$5,844,080.00) for Adults distribution, Five thousand dollars and no cents (\$5,000.00) for Administration expenses, under **Bonus Distribution**; which amends the **Total Fiscal Year 2006 Tribal Operations** to read Ninety two million four hundred seventy eight thousand one hundred ninety three dollars and twenty seven cents (\$92,478,193.27); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
