#### Ordinance 21-06

An Ordinance of Supplemental Appropriation, and Budget Revision for Health and Human Services, and Housing Initiative of the Executive Branch of Mille Lacs Tribal Government for Fiscal Year ending September 30, 2006.

The District III Representative introduced the following Ordinance on the 21st day of February, 2006.

#### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2006.

### Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Health and Human Services and Housing Initiative for fiscal year ending September 30, 2006.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Twenty seven thousand one hundred seventy dollars and seventy three cents (\$27,170.73) for WIC grant 220-450, Ten thousand four hundred twelve dollars and no cents (\$10,412.00) for Pharmacy 220-424 Self-Governance, Three hundred forty six thousand seventy nine dollars and no cents (\$346,079.00) for 1f Governance, under **Health and Human Services**; which amends the **Total Fiscal Year 2006 Tribal Operations** to read Eighty three million two hundred thirty seven thousand nine hundred thirty two dollars and twenty seven cents (\$83,237,932.27)

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
