#### Ordinance 23-06

An ordinance to amend Title 16 (Corporations) of the Mille Lacs Band of Ojibwe statutes to delete or change sections that are in direct conflict with the intent and scope of Title 15 (Gaming Regulatory Act) which was adopted on August 19, 2003.

The District II Representative introduced the following Bill on the 2<sup>nd</sup> day of March, 2006.

### **PREAMBLE**

It is enacted by the Band Assembly for the purpose of correcting Title 16 (Corporations) so as to delete or change sections that are in direct conflict with the intent and scope of Title 15 (Gaming Regulatory Act).

## Title 16 (Corporations)

**Section 1. Amendment.** Section 5 of Title 16 is amended as follows:

§ 5. Ministerial powers and duties of commissioner for corporate affairs.

The Commissioner for Corporate Affairs shall have the following ministerial duties:

- (a) To provide an effective and efficient system of administration for the Mille Lacs Band Business Corporation Act (16 MLBSA § 1001 et seq.).
- (b) To provide an effective and efficient system of administration for the Mille Lacs Band Nonprofit Corporation Act (16 MLBSA § 2001 *et seq.*).
- (c) To provide reporting and accounting for a Net Revenue Allocation Schedule in a form prescribed by the Band Assembly pursuant to 16 MLBSA § 108.
- (d) To provide an effective and efficient administrative system to license and certify Foreign Corporations under the Band's Commercial Licensing Statute (18 MLBSA § 1 et seq.).

The sections previously marked as (c) and (e) are hereby repealed in their entirety.

**Section 2. Amendment.** Section 106 (Enumerated powers) is amended as follows:

Section (e) of § 106 is hereby repealed in its entirety as the Gaming Regulatory Authority is charged with the responsibility of regulating gaming as per 15 MLBSA § 1 et seq.
