Ordinance 33-06

ordinance of Supplemental Appropriation and Budget Transfer for Education and Health and Human vices of the Executive Branch of the Mille Lacs Tribal Government for Fiscal Year ending September 30, 2006.

The District II Representative introduced the following Bill on the 22nd day of May, 2006.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2006.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Education and Health and Human Services for fiscal year ending September 30, 2006.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two hundred thousand dollars and no cents (\$200,000.00) for Emergency Services Elderly Energy, under **Health and Human Services**; which amends the **Total Fiscal Year 2006 Tribal Operations** to read Ninety five million three hundred fifty three thousand seven hundred two dollars and fifty eight cents (\$95,353,702.58).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental lds for the following:

Section 1.02.1: The Band Assembly hereby authorizes the transfer of programmatic funds for the following:

Education-budget transfer

201-304-7100 Vehicle/equipment amount transferred:

\$ 24,000.00

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
